Safety of Persons Attending Interment Service

Persons attending an interment service in accordance to their tradition, ritual or practice, may deposit a handful or shovel full of earth on the casket before it is lowered or into the grave after lowering with prior arrangements from the legal next of kin and applicable fee's are paid. They shall remain at a safe distance from the grave while depositing earth. Once complete all person's must move to designated distance from grave until backfill is complete and given ok from cemetery staff.

Removal of Debris from Markers

Every **Wednesday** all decorations and flowers will be removed and discarded in the Sections of Lower **4, 5, 6, 7, and 8**. Every **Thursday**, all decorations and flowers will be removed and discarded in the Sections **O, P, R, and S**. If you do not wish to have the items you've brought thrown away, you are welcome to come and remove them prior to our doing so. Artificial flowers and decorations will not be saved for any length of time by the Cemetery. In consideration of select holidays, decorations will be left in place the full week (a minimum of seven days) following **Valentine's Day, Easter, Memorial Day, Mother's Day, Father's Day, 4th of July** and **Dia De Los Muertos, Veteran's day, New Years**. Decorations and flowers placed the Friday before **Thanksgiving** will be left in place until the first Wednesday/Thursday of December. Decorations and flowers placed the Friday before **Christmas will be left in place until the second Wednesday/Thursday of January**.

Planting of Greenery

Please **do not plant flowers, shrubs, trees, etc...** Anything planted in the cemetery will be removed and either disposed of by means of throwing away, or replanted in another section of the cemetery that would be appropriate for the plants growth.
